1. About the Institution:

Rambhau Mhalgi Prabodhini (RMP) is a Mumbai based independent research and training institute, engaged in advocacy as a forum for exchange of thoughts and opinion making on various issues of public concern. RMP is the only institute of its type that provides capacity building training for elected representatives, voluntary social workers and persons running institutions.

Established in 1982, RMP is an NGO in Special Consultative Status with the United Nations. A sprawling facility in the outskirts of Mumbai called Knowledge-Excellence Centre (at Bhaynder, Dist Thane), a library with rich collection of books and monographs, various research-fellowships for young researchers, and independent units dealing with Institution Building and Leadership Studies, Human Rights and Natural Resources Management are the key features of the institutional profile of RMP. We operate through our offices in Mumbai, Pune, Delhi and New Jersey in USA.

Ownership Rights:

RMP will have complete ownership rights over the dissertation and all the related documents and photographs submitted by the candidate, RMP will have the rights to publish these dissertations or any part of it, without the prior permission of RMP. Those dissertations or part thereof that will be published after getting the permission from RMP, will have to bear a clear reference to Rambhau Mhalgi Prabodhini Fellowship Programme.

Over and above the topics short-listed for the respective year, the selection committee may also consider applications sent by aspiring candidates on their own, on topics of their choice.

Rules and Regulations:

- 1. After the topic has been chosen and approved, the candidate has to give a written promise on stamp paper, about completing the project work and presenting the dissertation.
- 2. Give an undertaking concerning acceptance of guidelines and rules/regulations of the fellowship scheme
- 3. Work under an assigned research guide all through the assignment. Every recipient of the fellowship will be working under the guidance of an officially appointed guide. The fellowship recipient will have to prepare the outline of this project, schedule of completion and also the scheme for the same in consultation with guide. Outline of the project and dissertation could be sent either in Marathi / Hindi / English. A schedule for disbursal of Fellowship Amount will be finalized in consultation with the guide and the same will be adhered to.
- 4. Present a comprehensive dissertation on the topic before the specific duration. (Failure in adhering to the schedule will make the candidate ineligible for the award of the amount of fellowship)
- 5. At the end of the period, the recipient will submit the final version of his dissertation to his guide. If need be, the guide may ask the recipient to improve upon his performance, so as to have his final approval. A recipient will have to abide by the instructions of the guide and introduce mutually agreeable

studious approach. The objective, very obviously is to give a sound research orientation to those who want to contribute through voluntary social work. The idea, essentially is to help Leaders of Tomorrow, a sound research base that would empower them with deep insight. This scheme, all in all, attempts to attract the attention of the student and non-student social workers and journalists as well, towards issues that are otherwise neglected by the media, despite being extremely important for the society as a whole. This scheme is operated for two groups. The first is Students Group and the second is General Group.

Eligibility for Students Group

All the students of journalism (degree, diploma or certificate course) are eligible for this scheme. Priority will be given to the students of Mumbai university based Bachelor of Mass Media degree course as well as the students of BSW and MSW.

There are two Fellowships instituted under this category. The details are as follows-

Application Forms:

Selection:

If necessary, interview session will also include a short written test component. This selection process will take place between February 1 and 10, 2015
