

Report of Sushasan Mahotsav

In an era where governance efficacy and public welfare hold paramount importance, the Sushasan Mahotsav proved immensely significant. Held in the heart of New Delhi on February 9th and 10th, 2024, Sushasan Mahotsav, presented by Rambhau Mhalgi Prabodhini (RMP), celebrated good governance, leadership development, and societal change.
