About Nation First Policy Research Centre

Nation First Policy Research Centre (NF) is a policy research group based in New Delhi, working closely with the government of India to advance policy ideas and assist in their implementation on the ground. NF conducts rigorous, in-depth research and employs systems thinking to arrive at creative policy solutions, and works in close consultation with the government and public institutions to implement the policies on the ground. NF undertakes both extensive, peer-reviewed research for long term projects, as well as incisive, quickturnaround research for actionable agenda.

NF achieves its aims by adopting the following roles:

- (a) To study existing and upcoming government policies, schemes and regularly provide research-based inputs & recommendations, propose policy reforms to the government,
- (b) To build a research-driven policy ecosystem that could be scaled up as a decisionmaking support system for political leadership,
- (c) To assist the governments and country's legislature in their research and informing more thoughtful legislations

Functionally, research at NF is manifested through its formal research as well as a Policy Observatory. The former develops background papers; situational analysis papers (problem statements); and approach papers (policy design). In addition NF also conducts impact evaluation of existing policy interventions. The Policy Observatory picks up and distils ongoing issues in country's policy world.

NF is dedicated to nation building, knowledge creation and solving India's problems. It is committed to the vision of India that is built on the foundations of gram swaraj, antodaya and sarvodaya.

About Research Group

The intellectual strength of NF is constructed out of its Research Groups, each engaging with a different policy domain. Each of these Research Groups remains as a specialized unit within NF, but with considerable pollination of ideas between these domains. Hence, we do not call them verticals but groups. We are conscious of the need for a system-based approach to solve



complex problems of today particularly in a diverse country like India, hence, use these distinctions as placeholders for domain knowledge, but not domain monopoly.

Each Research Group is headed by a Research Fellow, who will have Research Associates under her. These Research Groups will be responsible for both research and implementation of their policy ideas, but will draw comprehensively from the shared wisdom of the other Research Groups. It is therefore, often likely that the scholars and administrators in the Research Groups may not necessarily come from the same domain as that group, but from other diverse traditions. This allows for the necessary diverse thinking to sculpt an informed judgment.

The evolving Research Group list is as follows:

- 1. Agriculture (for e.g., agriculture-technology convergence, FPOs)
- 2. Development (for e.g., health and nutrition, labour and migration, tribal empowerment and island development)
- 3. Law and Governance (for e.g., police reforms, judicial reforms, simultaneous elections)
- 4. National Security (for e.g., border and coastal security, Islamic terrorism, Internal Security)
- 5. Education and Culture (for e.g., conserving Bharativa linguistic cultures)
- 6. Impact Evaluation (for e.g., to evaluate the impact of policy intervention)

At NF, like in the real world, structures and lists are ever-evolving. This means, depending upon the need of the hour, new Research Groups could be formed. The key point is necessary collaborations across groups, both formally and informally. At NF, we strongly believe in learning by doing, and intellectual humility allows new ideas to emerge, something NF is always proud of.

Position Summary: Research Fellow

NF is seeking dynamic and enthusiastic scholars-administrators to join the team as Research Fellows (RF). As mentioned earlier, each RF will be heading one or more Research Group(s). The RFs will need to drive the research agenda of their research group(s), establish collaborative engagements with the other research groups, as well as help build and add to the intellectually stimulating environment of NF.

As an RF, you will typically have a Doctoral or advanced Master's degree from a university whose commitment to academic excellence is undisputable. You will also have a policy research and/or policy implementation experience of about five to ten years, preferably in an environment which favours speed although not at the cost of rigor. One may want to draw an analogy from the background of an excellent consultant who has her feet tied to the ground and



who recognizes the value of good research; or an academic who aspires to work in an actionpacked environment and knows the need for sense of urgency in policy matters. In either case, the idea is to alloy a thinker and a doer, with a little bit of sense of humour (working with government extensively will require the last one the most).

Applicants with a fertile mind and dynamic attitude looking to work in a high action research environment, with an aim to make a difference in the lives of people, may find this opportunity to be of interest. Government, academia and industry will be the intersection of most of the work.

The appointment is full time, and permanent, based out of New Delhi. Travels will be expected.

Key Responsibilities

Research Fellows will act as Scholar-Administrators responsible for the quality and delivery of the work assigned to their Research Groups.

- Coordinate and organize continuous engagements with the governments, and members of Research Advisory Council of NF to advance the agenda of NF's Research Group
- Actively participate in, and where necessary help to organise research seminars, workshops and other research and training activities of NF
- Organize and attend consultative sessions with stakeholders
- Mobilize grants, projects, new programs and reshape policy thinking in NF inspired by immediate as well as long term local and global needs
- Publish in high quality, peer-reviewed articles in refereed journals
- Constantly publish opinion pieces and shorter op-eds in national dailies
- Ensure the quality management of any written produced by the Research Group(s)

Leadership & Administrative

- Actively participate at NF meetings and contribute to planning activities or other work to support capacity building in the organization
- Contribute to, or present research to the public to elevate awareness of important developments in the policy domain of the Research Group, and promote critical enquiry and debate within NF wherever appropriate
- Promote research, scholarly activities and outreach that will advance the academic/advisory excellence of other Research Fellows and Research Associates in research and professional capacity
- Demonstrate and promote values of NF including diversity of thoughts, knowledge creation and high standards of ethics and integrity
- Assist in internship and placement programmes of NF
- Represent NF at various national and international events
- Recruit excellent candidates for building a team of Research Associates

Selection Criteria

Essential

- A PhD in relevant subject from a globally reputed university, with outstanding educational qualifications, or an advanced Master's from an institution of global excellence
- An emerging teaching/research/advisory track record, demonstrated by policy experience (planning or implementation or both) and recognition of high-quality research outputs
- Experience in working with minimal supervision, and ability to prioritise tasks to achieve project objectives within timelines
- Demonstrated capacity to communicate research concepts to technical and nontechnical audiences





- Excellent written and verbal communication skills, demonstrated by presentation of research results at conferences, internal forums and through report submissions
- Ability to read and write in English quickly and effectively
- Excellent interpersonal skills, including an ability to interact with internal and external stakeholders (academic, administrative and support staff both within and outside NF)
- Ability to motivate and inspire teams
- Possession of good sense of the research and technology frontiers, with a keen eye on global trends related to the relevant discipline, both industrially, governmentally and academically
- Demonstrable record of cooperating and working with government bodies on various kinds of projects.
- Five-ten years of relevant experience of working in the domain area of the Research Group
- Ability to understand outcomes, its scalability and replicability
- Ability to draw large scale insights, as well as possessing an eye for detail
- Entrepreneurial understanding of dynamically challenging organizations and landscapes
- Strong EQ

Desirable

- Relevant exposure
- Experience or interest in cross-disciplinary projects
- Experience in assisting with supervision of scholars/administrators
- A demonstrated interest in research and policy innovation
- First class networking skills and an ability to build and nurture external contacts and partnerships, working with government organisations

Successful candidate is expected to report in New Delhi immediately after selection. Selection will be on rolling basis and we hope to fill the vacancy before March-April 2021.
